

In 2022, CADAL implemented the projects "North Korea in the spotlight", "Promoting Political Openness in Cuba", "International Relations and Human Rights Observatory", "Defense of Freedom of Artistic Expression", and "Democratic Governance Watch".

CADAL organized 20 events in 2022, out of which 15 were inperson, three were hybrid, and two virtual. Eleven in-person events took place in Buenos Aires, one in The Hague (Netherlands), one in Los Angeles (United States), one in Montevideo (Uruguay), and one in São Paulo (Brazil). Additionally, members of CADAL participated in events in Santiago (Chile), Paris (France), and the City of Mexico.







During this period, CADAL published **100 articles**, **8 reports**, and **45 communications** and counted **59 press appearances**. In the same vein, **47 interviews** were conducted on the series *Cuarto de Hora* by the journalist Jorge Elías and streamed on the channel CADALTV on YouTube, which currently has more than 4300 subscribers. Seven episodes of the podcast *Artistas en el Exilio* (English: *Artists in Exile*) were produced, following cultural icons of Brazil, Cuba, Equatorial Guinea, Argentina, and Venezuela.













Among 2022's significant activities were the following:

Campaign for Qatar 2022: *Don't taint the ball*. This initiative collected more than ten thousand signatures on the platform change.org.

The presentation of the 2019-2021 Prize for Commitment to Diplomacy concerning Human Rights in Cuba to Bastiaan Engelhard at the Netherlands Ministry of Foreign Relations headquarters in The Hague.
